We acknowledge our continuing need of God's grace, Jesus' love, the guidance of the Holy Spirit, and the support of our community in the fulfillment of this Covenant.

#### **AFFIRMATIONS**

At a large leadership retreat of our church in January 2006 a need was expressed to proclaim more clearly who we are and what we stand for as a church. Below is a list of affirmations that was voted by the church on May 6, 2007 and amended on May 5, 2019.

#### The Church of Christ, Congregational affirms these beliefs and commitments:

Vision Statement: United in Spirit and inspired by God's grace, we grow in faith and service.<sup>1</sup>

Mission Statement: This Church joyfully gathers to worship God. We proclaim and teach the Gospel of Jesus Christ while growing in faith and service. We pray for one another and for all humanity.<sup>2</sup>

We acknowledge that we are all on a spiritual journey, so we are moved to accept a diversity of belief and doubt.<sup>3</sup>

We accept as full members, with complete access to the rites of the church, and to service within the church, people of good will and faith, regardless of race, color, ethnic origin, physical ability, sexual orientation and status in society. In employment we also provide an equal opportunity.<sup>4</sup>

We affirm the Bible as our primary source of inspiration and understanding of God, but we do not necessarily adhere to a literal interpretation of Scripture.<sup>5</sup>

We affirm our belief in Jesus Christ, the incarnate Son of God, made known through the Holy Spirit.<sup>6</sup>

We affirm the right and obligation of the church to raise concerns about issues facing society, to critique the institutions of society which foster injustice, violence, racism, sexism and ageism and to act in response to these concerns. We affirm the pastor's freedom of the pulpit to proclaim the Word of God as it challenges the congregation to serve God.<sup>7</sup>

We care for God's Creation by adopting and advocating environmental stewardship that will preserve and restore Creation for our descendants and for all living things on Earth.<sup>8</sup>

We affirm the priesthood of all believers, and hold that each member has rights, privileges and obligations in the governance of the church and in the furtherance of its mission.<sup>9</sup>

Our interpretation of Scripture and the guidance of the Holy Spirit lead us to a faith that is full of hope, optimism and forgiveness. 10

#### Minutes of the Annual Meeting, May 7, 2023

The 300<sup>th</sup> Annual Meeting of the Church of Christ, Congregational, of Newington, CT was called to order at 11:24 AM with a prayer by Skip Collins, Moderator. Approximately 60 people were in attendance between the in person and online Church members.

There was a correction to the deacons and it was confirmed that Susan Kalman is a member of the deacons. Her name was accidentally omitted from the annual report.

1. Receive the reports of the Officers, Boards and Organizations and delegates were distributed. All members had the opportunity to review the Annual reports prior to the meeting and are encouraged to read through all reports.

### Motion was made to accept the reports as presented, there was a 2<sup>nd</sup>, no discussion and reports were accepted by unanimous vote.

2. Present and approve the slate of officers that are to take effect on June 1, 2023.

# Motion was made to accept the Church officers and Board members for the June 1, 2023, there was a 2<sup>nd</sup>, no discussion and they were accepted by a unanimous vote.

3. Present the revised Church Covenant. The September 22, 1963 version and the revised version dated May 2023 are attached.

Prior to presenting the revised Church Covenant, Chuck Hasbrouck, gave a background as to the purpose of the Covenant which actually dated back to the 1500s of England. The revisions then went from the deacons to the council and the council approved.

The Annual Financial Meeting of the Church of Christ Congregational was called to order by Skip Collins, Church Moderator, at 11:20 AM. Approximately 50 + members were in attendance and quorum was met. We met in the Church Sanctuary. Reverend Melanie Enfield opened the meeting with a prayer. Skip Collins chaired the meeting.

### 1. Receive the reports of the Treasurer, the Board of Christian Stewardship, and other financial reports of the Church.

All members had the opportunity to review the Annual Financial Reports prior to the meeting and they were encouraged to read and review the information in the reports. Jim Mulrooney, Treasurer, reviewed the following:

We had a very good year financially and we are financially sound. Jim reviewed the exhibits in the report.

Heather Beattie DeWitt reviewed the budget in detail for both the 2023-2024 year and for the 2024-2025 year. The 2023-2024 year was used as a plan for the 2024 year. The endowment transfer is 5% and the most we can transfer is 6% The actual budget has a credit totaling \$9,142. For further details, see exhibit in the 2023 Financial Reports.

Mark Russell joined the Trustees in October 2023 and will be taking over as budget coordinator.

Kent Stoddard ask to clarify the endowment interest and Mark explained how it worked.

Julie Wacht asked about the shared expenses from the tenants and that was explained.

#### 2. Consider and adopt the proposed budget for 2024.

Motion was made to approve the 2024 Church of Christ budget as presented. There was a second. The Church of Christ Congregational 2024 budget was approved by unanimous vote.

Paul Paiaia thanked all those who were involved in the budget process.

Skip asked for if there were any other questions and discussion.

Skip Collins ended the meeting with a prayer at 11:40 AM.

A motion was made to adjourn the meeting and was accepted by unanimous vote.

## Annual Report Spring 2024 Rev. Melanie Enfield Senior Pastor

As I consider all that has happened this past year my heart is full of gratitude and I am reminded of the verse from I Thessalonians, "Give thanks in all circumstances." (5:18) My year began with a wonderful sabbatical last summer! I needed the rest, the break, and the inspiration. Thank you for this gift. It was greatly appreciated.

When I returned in September, we had hired a new office manager, Michelle Dixon, who has been a great addition to our staff. Michelle keeps us all organized with what is happening in the building. Michelle, Bria and Mary Jane make a great team and their strengths compliment one another. I am grateful for our office staff, for when things in the office run smoothly, it helps me do my job! Then after an 18-month search for an Associate Pastor, we switched gears, and we hired Tobey Aubert as our Program and Outreach Coordinator. Tobey has brought good energy and passion for this new position. I look forward to working with him as the year progresses. Peter Niedmann continues as our Director of Music, and Glenn Casey and Bob Pinard as our Sextons. It feels very good to have a full staff!! I am grateful.

This past year I enjoyed leading two different Bible studies, one in the fall on the Book of Philippians, and one during Lent on the Witness at the Cross. Jim Mulrooney helped lead both classes. Our sessions were full of good discussions and learnings. I also co-taught confirmation every Monday afternoon with Janet Schneider. We had lively conversations with 4 teenage girls about life, faith and the Church. I am grateful for all of them and also the confirmation mentors who walked alongside of us this year.

A big part of my week is planning worship and preparing my sermons. I try to have some variety. We have had a good number of visitors come on Sunday morning and it is always a challenge to meet and get to know them. (thank you, Deb Jeanfaivre, for your help in the area!) Advent/Christmas season, along with Lent/Easter are busy times, yet they are fun to plan and prepare for. In the fall we held a 4-week worship series on blessings. Each week we offered a blessing for a particular circumstance. (Blessing of our hands, for those in pain...) The week we offered a blessing for those who were addicted, or those who love someone who is addicted was a very moving worship service. We give gratitude to the people who were willing to be open and honest about their lives.

Our online presence continues to be strong, typically we have over 100 views on our YouTube channel each week. The number of subscribers to our YouTube channel has also

steadily increased this year. I have officiated at plenty of baptisms, one wedding and a number of funerals, these sacred times are always a highlight for me.

I have enjoyed spending time with our FUSE and SALT groups this year and am grateful to our youth advisors and our church schoolteachers! I am thankful for their faithfulness to God in sharing the good news of Jesus Christ. We all want to have a strong youth program, but only a few really jump in and do the work! Thank you! We had great discussions with the high school kids at my house for dinner and conversation. The sleepout is always a good time, and our caroling party at Christmas is meaningful. Family First Friday has also continued this year, and I have enjoyed getting to know some of the younger families of our church.

Besides my work in this particular congregation, I am also connected to the larger church through the Connecticut Central Association where I am the chairperson of the Committee on Ministry (COM.) The Association COM is where pastors hold their ordination status. So, we work with members in discernment (those who are working toward ordination) and those pastors transferring in or out of our association. We also work with Churches who are struggling in one way or another. At the present time, we are conducting a Situational Support Consultation with a local church that is experiencing conflict. I also attend monthly clergy gatherings for the association and also participate in the Newington Interfaith group. I am the facilitator for a clergy excellence group that meets once a month and encourages pastors to use their gifts for the greatest good.

During this past year we have also been in conversation with our friends at the Elmwood UCC Church. Elmwood has voted to become a legacy church, and some of their members have considered joining our congregation. In March, our council hosted a dinner with them and had a good time getting to know one another.

As I reflect on this past year, I am indeed grateful to this community of faith, for the love and support you share with me, and especially for your faithfulness to the Church of Jesus Christ. My prayer is that we will continue to listen, to act and to love.

#### Program and Outreach Coordinator Annual Report 2023-2024

In the past two and a half months that I have been in the position of Program and Outreach Coordinator I have had the privilege of getting to know our church family in a number of settings. Participating in worship services and visiting Sunday School classrooms has been a delight, especially being here for Holy Week. I have enjoyed hanging out in homes, church and bowling alleys as well as serving meals in Hartford with our high school and middle school youth groups. Being able to sit in and contribute in board meetings and at council have been insightful into the caring hearts and willing hands of our congregation. I am blessed to be able to be a part of Family First Fridays this spring. All of this along with a lot of fun in the fellowship hall and chatting in the Narthex has made me feel welcomed and loved.

While getting to know the congregation in those ways, there have been two distinct goals in my mind: assessment and focus. I have assessed the needs and attributes of our church and the needs of the Newington area through a variety of methods. Processing the Strategic Plan and the source documents combined with individual and group discussions have revealed a church that is healthy and ready for the next stage in more effective impact in the community. Combining the information from the Strategic Plan and interviews with members of our congregation initiated a pursuit of clear descriptions of purpose and passion to define our congregation for the future.

We explored three types of questions. The first question type is Our Why statement: What do we want to be known for believing? Why are we here in this place at this time? In listening to stories of recent and long-time members a common thread of the loving acceptance of God emerged which resulted in this answer, "We believe God loves unconditionally and inclusively." The second question type is Our Worthy Cause statement: What do we want to be known for doing? What is our dream? Through the Strategic Plan three categories of needs emerged involving relationships, wellness, and service in the Newington area, which resulted in the answers, "We dream of a connected, stable, and fulfilled community." The third question type involved Our Action statement: How can we declare our intentions in an easily recognizable manner, which resulted in the answer, "We choose to love on purpose to realize that dream."

In April, we brought the Focus Language to the Council for discussion and affirmation. The next step is to integrate the Focus Language into all areas of our church. That includes our planning process for marketing, themes for worship services, curriculum for programs, and decisions to create a streamlined calendar of events that provides effective impact leading to spiritual and numerical growth in our community.

The third step will be the invitation stage where we use distinct parts of these three statements to inspire each other within the church and attract folks outside our church to be part because our Why touches them and our Worthy Cause is something they want to make happen with their families, neighbors, and the community.

I am so glad to be a part of this church family and I am excited for the impact this will bring to this community and our own lives coming in the near future!

#### ANNUAL REPORT 2023 - 2024

#### From the Organist & Director of Music

Our music ministry is vibrant and strong. The choirs (Youth, Adult, Handbell) presented a wide variety of wonderful music for worship. They also performed in 2 concerts to large, enthusiastic audiences. The choirs deserve our gratitude for their ongoing commitment.

We also welcomed 2 guest music groups into our worship this year:

Sacred Steel, a steel pan group from New Haven, provided special worship music on Christ the King Sunday in November. The Hot Cat Jazz Band brought us joyful sacred jazz in March.

A special benefit concert to support the people of war-torn Ukraine was presented by pianist Victor Markiw in October. A substantial donation was sent to Ukraine, from a generous audience and other supporters.

Concerts presented this year: Notes Over Storrs (3 *a cappella* groups from UConn); Christmas by Candlelight choral concert, Scott Lamlein, organist; Spring Pops!; Bells on the Green.

Janet Schneider led a popular multi-week music program—CherubSing! for young children.

The Youth Choir will combine with 4 other choirs to sing a beautiful Evensong service at Trinity College Chapel in June.

Thank you to everyone involved in our music ministry: Choirs; Kris Dunn and Mary Jane Pfordte, choir librarians; Board of Music; staff. We are blessed with many talented, generous, and positive folks who work hard to make our worship life a beautiful experience.

### Board of Trustees Annual Report 2023-2024

The Board of Trustees has the responsibility as stewards of the church to oversee the maintenance of our property and the financial health of the church. Our church family continues to show amazing commitment with their time and finances. We are truly blessed.

#### **Financials**

Our 2023-2024 Annual Stewardship Campaign resulted in a total pledge amount of approximately \$411,000. This is slightly lower than our 2024 budget. We anticipate an increase in our basket/Non pledges, and our Shared expenses income remains strong and steady. As part of our 2023 budget, we transferred the full amount of \$64,825 from our endowments. We ended the 2023 fiscal year with an income of \$29,221 more than our 2023 budget. Our Expenses were down for the year, due mainly to not hiring an Associate Pastor and partial year without an Office manager.

The 2023 fiscal year ended with a Surplus of \$91,482. The trustees have placed approx. \$65,000 in our Fidelity funds and created a Trustees Discretionary account within our Power church accounting system. This will allow some flexibility as we navigate increased salaries, Mission needs and building maintenance. We pray that God will continue to bless and guide us and that we can continue as a strong and vital church, performing his work every day.

We carefully observed our endowment funds, which grew substantially due to a strong 2023 market performance. As always, we seek to balance return vs. risk in accordance with our guidelines. We continue to look at the most efficient way to invest our funds and we navigate the current markets and stay consistent with our financial policies and procedures. A special thanks to the Investment Subcommittee. This group of experienced church members always have the best interest of the church in mind.

The Trustees are consistently monitoring the costs of operations including utility rates, insurance, maintenance cost, investments, along with use of building and safe egress for everyone.

#### **Maintenance**

For building maintenance and repair, we continue to focus on ongoing preventative maintenance of our aging building. We successfully completed significant projects such as, but not limited to:

- We continued with the long-term plan of replacing windows in the building.
- We began the long-term project of removing the building away from the aging pneumatic controls as we converted four more upper floor rooms over to electronic thermostat control.
- Volunteers performed various painting projects throughout the building.
- We continue to repair aging floor tile and carpet as we plan and budget for replacement flooring in the Fellowship Hall and Narthex.

#### **New Center Corp.**

We continue to work closely with the dedicated church members who manage the New Center Corporation, on our behalf. In 2023 M&T Bank opened the branch and we have seen an increase in traffic and patrons at both tenant spaces. We continue to maintain the property and monitor our lease agreements.

#### Personnel

The church has hired a part-time office manager. Michelle Dixon was hired as a temp in early August, and we were very impressed with Michelle's experience with faith-based organizations. We hired Michelle as a church employee in early November 2023 and look forward to many years of employment. Mary-Jane DiPaola, our financial administrator, continues to perform her financial responsibilities very well. MJ works closely with the Trustees and the Treasurer to maintain a good standing with all our accounting and bookkeeping. Bria continues to perform her work responsibilities with easy and efficiency. The Sexton duties were performed by Bob Pinard and Glenn Casey. Both men perform their duties very well, keeping our building clean and safe for us all. We appreciate all their efforts. We have also hired Tobey Aubert as our Program and Outreach coordinator. This new position came from our difficulty filling the Associate pastor position. Tobey is a hybrid employee that falls under the direct supervision of the Pastor and falls under the category of Lay staff. We welcome Tobey and look forward to his energy and ideas to help us grow into the future. We have a very good staff, with impressive talents and skills. They all work very well together, with Rev. Enfield and the entire church volunteers.

#### **Shared Expenses**

We also want to extend a Thank you to all the other groups who share in the expense of church building. Baby Bees Preschool, Wellspring Ministries, various groups such as Al-Anon, NA, MADD, and other one-time events. This past spring we added Weight Watchers. WW uses the Fellowship Hall for five sessions weekly, Thursday through Sunday mornings. We have been fortunate to have them and look forward to a full year in 2024.

#### **Strategic Plan**

As highlighted in our current Strategic plan, we are focusing on the second year of our plan and goals. That includes continuing the process of accessing our underutilized building spaces. We are open to new and exciting opportunities to offer spiritual and faith-based growth within our community.

#### **Board Members**

#### Board of Deacons Annual Report – 2023–2024

The 'small but mighty' Board of Deacons is a dedicated and talented group that has done some outstanding work this year. Who are we? Linda Crawford, Peg Garrison, Jamie Harris, Dale Hasbrouck, Chuck Hasbrouck, Sue Kalman, Peg Kelly, Dave Kilpatrick, Ann Marino, Karyl Sadowski, Theresa Swenor, and Mary Woods. This hard-working group has accomplished some wonderful things this year.

The church year began with the adoption of our Church Covenant in May 2023, revised by the Board of Deacons during the prior year. The Covenant will serve our church well for the future.

The Deacons Manual, previously an out-of-date and inaccurate reference document, is used for all our activities. Deacons carefully updated it to align with current practices and future needs.

Another outdated document is our church membership list. A subcommittee has been reviewing the rolls and communicating with members who have not been active to determine their ongoing membership level. This time-intensive and difficult work continues.

With COVID in the rearview mirror, our church returned to the traditional communion service. With parishioners having a growing comfort level with the traditional bread and juice elements, this year we began to use home baked bread for communion, prepared by volunteer church members, adding varied nice flavors to the sacraments each month.

As an open and affirming church, the Board of Deacons want to be sure that we talk the talk and walk the walk. The Deacons recommended changing the designations of three handicap-accessible bathrooms from gender specific to 'All Gender Restroom'. They are located on the first level near the narthex and near Fellowship Hall.

Wanting to ensure that the public knows that our church is a welcoming place for everyone, Deacons resurrected the Pride Doors, displayed near the church sign at the corner of Cedar and Main. The doors were seen in June 2023 and will be again in June 2024.

Continuing efforts to provide spiritually meaningful holiday seasons, Deacons designed and installed an Advent alter scape and displayed seasonal flowers at the communion table for Christmas and Easter. As has been the practice for many years, the flowers were distributed to designated church members under the leadership of the board. Deacons took the lead again this year for our church's role in the town Parks & Recreation Department's *Night of Lights*, a highly successful community activity.

With all the stress we encounter in our lives, Deacons installed the Prayer Door in the narthex for the months of March and April. People were encouraged to write concerns on prayer cards and place them on the door, leaving their worries to God before entering the sanctuary.

In addition to communion, deacons are part of many church services, including weddings, funerals and memorial services, baptisms, and new membership.

With great appreciation to the Nominating Committee, the Deacon Board looks forward to welcoming four new deacons for the coming year.

We held the annual Christmas Eve family service - a great time was had by all.

In January we started an attendance award program to keep up our attendance numbers during the winter. Pre-K through 3 are able to pick from a prize box after 5 Sundays. Grade 4-7 will receive a \$5 dollar gift card to Dunkin or Carvel after 10 Sundays. This was our strategic goal for 2023-2024.

#### **Thrift Shop Annual Report 2023-2024**

We are still here at 230 Market Square (rear), and thanks to our amazing volunteers, shoppers/customers, and those that donate items, we seem to be doing better than ever! For those not aware, we are a thrift shop, sponsored by our church, run by church-member volunteers, and dedicated to serving the needs of our church and community near and far.

Our proceeds enable us to "gift" the church and its boards with funds to help with their events, needs "wish list" items and such.

We continue to donate yearly to the Music Board for Peter's concert series, the Missions Board for "Hands on Hartford," "Got Lunch," and Friendship Center, and to ASP for their youth ministry trip. In addition, we always "invite" the ASP volunteers to come to the shop to pick out work-clothes (jeans, shirts, shoes, etc.) at no charge (FREE) to wear on their trip. We also donate yearly to the church golf tournament.

In support of our community, we donate yearly to our local Newington Volunteer Fire Department Co 1, and our Newington EMS. In the past we have donated prom gowns in the spring for young ladies in need to local drop-offs, but this year, thanks to our church collection drive, we were able to bring the gowns and some glamorous shoes right here! Also, to extend our outreach to the community, clothing and household items that don't sell are always donated to other charity venues, such as The Salvation Army. We even donate household items to the June ASP tag sale!

Over time, we have developed a close rapport with many of our regular customers, and that number continues to grow. More and more people are coming into the shop saying they no longer want to pay the high prices in the stores. They comment on how nice the thrift shop is and especially how friendly and helpful our volunteers are. Just to note, if a customer comes in and is interested in an item(s), but came without cash or a check, we will hold that item(s) for them (usually for one week).

Everything we sell is donated, including men's, women's, baby, and children's clothing and shoes, purses, dishes, vases, glassware, paperback books, puzzles, costume jewelry, knick-knacks, linens, pots and pans, toys, and much more. As of

last year, due to state regulations, we can no longer sell small counter appliances (toasters, irons, mixers, toaster ovens, etc.). We continually run 50% off sales that change every 2 weeks on various items.

Our volunteers sign up for shifts of two hours each, either 11:00 until 1:00 or 1:00 until 3:00. We have some volunteers that act as "fill-ins" to cover for those that have signed up but can't come that day.

#### ASP 2023 Annual Report

Love Strong Luke 10:27 Love the Lord your God with all your heart, with all your soul, with all your strength and with all your mind and love your neighbor as yourself.

ASP 2023 begins with monthly meetings to build our relationships with each other and to learn about ASP's three S - safety, sensitivity and stewardship. This year we added an ASP Game Night in January and enjoyed a fun night together. Fundraisers like the car wash and tag sale are hard work with financial benefits that also give our volunteers an opportunity to share with shoppers what ASP is and why they want to participate . As we attract many student volunteers from Newington, these events facilitate team work and highlight their strengths that we can build upon during our trip.

This year we had 43 volunteers: 16 veteran adults and 27 youth with 10 who were new and 4 college age. This translates into 7 work crews with one floater, 8 rental vans. That means 7 families will receive work to make their homes warmer, safer and drier.

Our mission trip took us to Charleston, West Virginia where we stayed at Bream Memorial Presbyterian Church near the Kanawha River. This is a downtown church which also functions as a daycare and provides showers and laundry for the homeless. Being downtown brought some challenges: vehicle safety overnight, building codes, inspections, indoor storage of materials and fireworks viewing from our parking lot. The men's sleeping quarters in the gym needed to be expanded to accept the sea of cots and the women added another room. conditioner. We shared our week with another church from Pittsburg, PA They brought Lou who delivered prayers and freshly made snow cones from his trailer to our work site almost every day.

On our first night in Charleston, ASP CEO Walter Crouch visited our center and presented us with a 30 year participation plaque. This was a great honor for our church to receive and from Walter whom we have served with these past 30 years. He is retiring this April. Our work the week of June 23-27 included deck removal and replacement, building ramps, room additions, J channel for siding, roofing and ceiling repair. Many teams dug many deep holes by hand. We were blessed with warm, sun filled days. As relationships with our families grew so did the invitation to a basketball game and attendance to the weekly picnic. Several went to visit with families from last year. Our circle of Love Strong continues. So many lives changed for the past 30 years, none could be accomplished without the love and support of this church family. You support us financially and spiritually, you attend our fundraisers and give us much needed emotional support, you follow us on facebook and your comments uplift us. We are one body with many ways to bring God's love to our neighbors in Appalachia.





Accordingly, this strategic plan has been developed from a place of gratitude and abundance.

The goals and strategies in this plan seek to build upon the great work we are already doing—They focus on areas of opportunity and growth, as opposed to areas to sustain. Therefore, under each goal, there is also an affirmation or acknowledgement of the many strengths that serve as our foundation.



# GOAL 1: GROW IN OUR FAITH AND SPREAD THE WORD OF GOD THROUGH OUR DIGITAL MINISTRY, SPIRITUAL FORMATION OPPORTUNITIES, AND INTENTIONAL WELCOME OF ALL.

Affirmations: Our Church currently helps us grow in faith through compelling Sunday services, enhanced by beautiful music and online access; spiritual formation classes and Bible studies that also promote a sense of belonging; and a culture that values love, acceptance, and the active practice of faith. The following strategies build upon these strengths.

#### Strategies:

- Increase access to the word of God and connection to our Church by growing our digital ministry.
- Inspire more people to explore their faith through thought-provoking, creative, and tailored programs.
- Be more explicit in our intentional <u>welcome</u> of people of all abilities, orientations, races, and cultural backgrounds.
- Ensure all visitors and new members receive deliberate welcome and cultivation.



## GOAL 2: EXPAND THE MEANS, METHODS, AND RELATIONSHIPS THAT WILL ENABLE US TO CONTINUE GROWING IN SERVICE AND ADVANCING JUSTICE.

Affirmations: Service is considered a vital and empowering extension of our faith, and our congregants serve generously. Our broad range of service opportunities for youth and adults is noteworthy and appreciated, and our ministries align with critical community needs like housing, food, and economic insecurity. Community leaders value working with our Church, and we are seen as a reliable and responsive partner. The following strategies build upon these strengths.

#### Strategies:

- Increase the visibility of and participation in one-time and ongoing service opportunities.
- Provide education and forums to address racial, social, and environmental injustices.
- Develop an intentional community outreach strategy aimed at fostering relationships and expanding our collaborations to address community needs.
- Strengthen our presence in the community by increasing our participation in Newington groups and events.
- Invite the community into our Church more regularly and create a safe space for building relationships.

## GOAL 3: ORGANIZE MORE EFFECTIVELY, ACCESSIBLY, AND INCLUSIVELY TO ADVANCE OUR WORK.

Affirmations: The dedicated volunteers engaged in our Church's many boards and committees drive our mission and ministries. They are responsible for the spiritual life of the Church, grace us with music, nurture our youth, reach out to the community, invite people in, steward our resources, and so much more. We honor their immense contributions to every aspect of our Church and invite more members to answer this vital call to become a lay leader. The following strategies build upon our strengths and encourage changes that will promote more participation.

#### Strategies:

- Create onramps for committee service and more intentionally develop our lay leaders.
- Examine streamlined and enabling committee structures.
- Engage and empower our youth as the next generation of Church leaders.

## GOAL 4: MAXIMIZE OUR AVAILABLE RESOURCES AND INVEST WISELY IN OUR INFRASTRUCTURE.

Affirmations: Our lay leaders have dependably safeguarded and nurtured our Church's resources for 300 years. In a time where so many churches are struggling, our finances, building, and membership are in admirable shape because of their diligence and the faithful generosity of our congregants. From New Center Corporation to the use of our preschool space and Fellowship Hall, we also have a history of thoughtfully and creatively using our property to help sustain our Church and contribute good to the community. Now, as we consider the Church's value, relevance, and role in a rapidly changing society, we stand ready to ask new questions, explore new ideas, and continue boldly answering God's call. The following strategies build upon our legacy and call upon us to embrace an abundance mindset.

#### Strategies:

- Use our building needs and use audit to plan for capital improvements and explore our untapped potential.
- Promote abundance through the prayerful solicitation and use of financial resources.
- Invest wisely in our staffing and infrastructure.

#### INVESTMENTALITION AND PROGRESS MONITIORING

The strategic planning task force and Senior Minister will identify year-one priorities and share them with the Church Council. An implementation spreadsheet also will be created to track assignments and support progress monitoring. At that point, the Church Council will assume oversight of the plan and serve as a resource for committees.

Each committee will prayerfully review the plan, identify opportunities to contribute to the work, and submit a year-one workplan to the Council that outlines their ambitions. Progress by each Committee will be included in their regular updates to the Council. Sharing what worked, what didn't, and what was learned will be important as we all seek to continue experimenting, learning, and growing together.
